PROBLEM1-Sahil and Meeta are happily married for the past 07 years. But of late Meeta is not happy with her marriage as Sahil is really busy and hardly gives her any time. Sahil has a well-paying job where he keeps travelling out of country for work. Meeta is a homemaker and loves doing social work. Meeta while doing her social work meets Jordan who is a Soap Opera actor. The both instantly develop a liking towards each other and start an affair. The affair lasts for about Six months, after which Meeta realizes her mistake and ends the affair and starts working to give a fresh start to her marriage with Sahil.

Jordan on the other hand is furious with Meeta to end things on such a note, so he approaches Sahil and tells her all about their affair. Sahil gets really mad and furious with Meeta and plans to take revenge. Sahil along with Jordan plans to kill Meeta.

Sahil and Jordan make a plan that when Sahil is out with his friends that would be an appropriate time to kill Meeta as Sahil will have an alibi. Sahil hands over a spare key of the service door to their apartment to Jordan which is kept for the servants to enter and exit. Sahil tells Jordan that Meeta returns home every night at 7 PM, by 7.15 she enters the kitchen to get something to eat. He asks Jordan to enter the house before that and hide in the kitchen and when she comes to the kitchen at 7.15, Sahil will make a call to their landline which is fixed in the kitchen, as soon as Meeta takes the phone call, Jordan will attack her from behind and kill her, he also insists that Jordan should not cut the phone and let Sahil listen to her screams and pain and enjoy every bit of it.

Sahil and Jordan agree upon the same and Sahil agrees to Pay 50 lakhs to Jordan for the same, he pays an advance of Rs. 5 Lakhs the same day. The day arrives and Sahil goes out with his friends. As agreed by him and Jordan, he calls up his house at 7.15 PM. As soon as Meeta picks up the call, someone attacks her from behind, and Sahil keeps hearing as Meeta screams.

Sahil cuts the call feeling delightful as his revenge has been successful. He reaches home by 8.30 PM. The moment he opens his Apartment door, he sees his wife bruised badly, sitting in the corner in a state of shock with a knife in her hands full of blood. To Sahil's surprise Meeta was still alive but she was hurt. Sahil asked her what happened, to which she points out to the kitchen. Sahil hurriedly rushes to the kitchen and see a masked man lying in the pool of blood. Sahil quickly frisks him and takes out the spare key that he had given to Jordan. He finds the key and puts it in his pocket. He also takes out the mask of the Dead Body and to his shock and surprise the dead body is not of Jordan.

He immediately rushes and with the help of a screw driver brakes the lock of the Service Door of his apartment, to make it look as a forced entry, and after removing his finger prints from the screw driver Sahil, hides the screw driver in the dead man's pocket. While doing so, he has foot marks all over the kitchen covered in blood. By this time the police were on their door who were informed by Meeta a while back.

4. All Murders are Culpable Homicides but all Culpable Homicides are not Murders Support your answers based on the above Problem 1? (C.O.NO.1.3.4) [Application]

PROBLEM 2: Cersei lives in a student flat with three other students who all share the kitchen. Cersei is becoming increasingly annoyed by the fact that someone else in the flat has been taking her food without asking, and she decides to teach this person a lesson. She grates ten laxative pills and mixes them into a new packet of muesli before placing the packet in a kitchen cupboard. She supposes that whoever eats the muesli might suffer some pain and discomfort, but hopes that it will not lead to anything too serious.

Tyrion, one of Cersei's flat-mates, helps himself to a bowl of Cersei's muesli. Tyrion quickly develops diarrhoea, and since he suffers from Irritable Bowel Syndrome, his symptoms are particularly severe. Tyrion's other flat-mates, Arya and Sansa, start to become worried about him after he continues to be violently ill and is unable to attend University to submit his coursework. Cersei resolves not to help Tyrion, since she thinks he has got what he deserves, and refuses to get involved when Arya and Sansa suggest that they call a doctor. Arya and Sansa decide that if Cersei cannot be bothered to get involved then neither can they, since they are not even on the same course as Tyrion and hardly know him. Eventually, three days after ingesting the pills, Tyrion speaks to his mother on the phone. Tyrion's mother is so worried that she calls an ambulance which takes Tyrion to hospital. After a further week in hospital Tyrion recovers, but his Irritable Bowel Syndrome is aggravated by the episode and he is left having to take medication to control the condition for the foreseeable future. The doctors suggest that had Tyrion received treatment when he first became ill, he would have suffered no long-term ill-effects.

- 3. Akshay, a senior Police Officer, one day invited three of his junior officers to his house to have sexual intercourse with his wife Tina. The junior officers at first were reluctant but were persuaded that Akshay's invitation was intended to be taken seriously. Once they arrived, Akshay gave them contraceptives to wear. One day while returning from school Naman picked Malti up from school. Upon asking him Naman told Malti, that her mother Pooja had some work so she asked him to come and pick her up. Naman gave her some biscuits to eat, after which Malti fell unconscious. Naman took her to the International Airport and they boarded the Air India flight flying off to Canada. He passed through the security check by making Malti sit on a wheelchair and telling the authorities at the airport that she was sick. The flight took off and they reached Canada. In fear of being caught Naman took Malti to one of his Colleague Pritam's Place and they stayed there for a week. One of the days when Naman was out, one of the house helps in Pritam's house Bella took Malti to her house and hid her there by giving her a sleeping injection. She then called two men Bala & Raka who used to deal in Child Trafficking. Bella sold Malti to Bala & Raka for 50,000 Dollars. The men took Malti and forced her into child prostitution. Back in Pritam's house when Naman came back he madly looked for Malti but resisted going to the police as he knew that he got Malti to Canada by using illegal means. Discuss the Liability of all the people involved in this case. In the meantime Pooja filed a missing Complaint of her daughter Malti. Kindly Advise Pooja as to what are the legal options available to her.

6. P, Q, R, S, T and U are all unemployed friends who travel to Mumbai in search of jobs from their village. P and Q get a job with the local goon in Mumbai, who deals in Illegal arms. R and S get jobs as construction workers for a building and T and U remain unemployed. It is difficult for all friends to make ends meet so they all decide to rob a nearby bank. They take help from P and Q in arranging of two revolvers just as a precaution. T and U arrange for a second hand vehicle from a nearby garage, all friends chalk out the plan as to how they will rob the bank and how the plan should be executed. P and U have disagreements on certain aspects where they even get into a fistfight but are stopped by the other friends. As the day arrives, all of them take the vehicle and drive off to the bank, once they reach the bank, T gets nervous and asks everyone to go back and not to go ahead with the plan, but is snubbed by everyone. T gets out of the car and says "I cannot be a part of this plan" and runs off, the remaining ones go inside the bank, U waits by the vehicle keeping the engine running. They enter the bank and show the revolvers and shout "No one should move or else we will kill you". P and Q goes to the Manager's room, shows him the revolver and forcefully takes him to the bank's safe, the manager opens the safe door, and P and Q start looting all the money inside the bank.
