Decide with the help of relevant provision and case laws whether this challenge will succeed or not. Support your answer with reason.

Kartik Aryan purchased property in Marine Drive in good faith without having notice of the option of Salman Khan. Kartik Aryan files a suit for the possession of Marine Drive property.
