1. What is the significance of international criminal tribunals, such as the International Criminal Tribunal Rwanda and International Criminal Tribunal for the former Yugoslavia, in setting legal precedents and promoting the development of jurisprudence pertaining to the crime of genocide?

Individuals experiencing homelessness encounter discriminatory practices, limited availability of fundamental resources, harassment from law enforcement officials, and are deprived of their entitlement to adequate housing and respect. A cohort of human rights advocates and legal experts have resolved to commence a public interest litigation (PIL) before the Supreme Court of Republica, in order to safeguard the rights of individuals who are homeless, in light of the aforementioned circumstances. You are the lawyer representing the human rights advocate. Advice. (The laws of Republica shall be read in accordance with the laws of India).

4. You are a policy advisor for a government agency tasked with promoting human rights. What policies and initiatives would you recommend to address discrimination against marginalized groups in your country?
