NEW DELHI: Ratings agency CARE has downgraded credit ratings of Fortis Healthcare Ltd and one of its subsidiaries, the hospital firm told stock exchanges today. The long-term bank facilities for Escorts Heart Institute and Research Centre Ltd were downgraded to a 'Single A Minus'; "under credit watch with negative implications", from a 'Single A Plus' and "credit watch with developing implications". Its short-term bank facilities were given an 'A Two Plus' rating, revised from an 'A One Plus' rating. "FHL's ratings continue to be on credit watch in view of the sizable reduction in promoter's stake i.e. Fortis Healthcare Holdings Pvt. Ltd. (FHHPL) in FHL in the past year," stated a CARE Ratings press note attached by Fortis in its disclosure.
