Michael and Gwyneth are happily married for the past 10 years. But of late Gwyneth is not happy with her marriage as Michael is really busy and hardly gives her any time. Michael is a business tycoon and keeps travelling out of country for work. Gwyneth is an Art Collector and a Socialite. Gwyneth once goes to an art exhibition and meets Alan who is an upcoming artist. The both instantly develop a liking towards each other and start an affair. The affair lasts for about Six months, after which Gwyneth realizes her mistake and ends the affair and starts working to give a fresh start to her marriage with Michael.

Alan on the other hand is furious with Gwyneth to end things on such a note, so he approaches Michael and tells her all about their affair. Michael gets really mad and furious

with Gwyneth and plans to take revenge. Michael along with Alan plans to kill Gwyneth and plan the whole thing.

Michael and Alan make a plan that when Michael is out to play cards with his friends, that would be an appropriate time to kill Gwyneth as Michael will have an alibi. Michael hands over a spare key of the service door to their apartment to Alan which is kept for the servants to enter and exit. Michael tells Alan that Gwyneth returns home every night at 7 PM, by 7.15 she enters the kitchen to get something to eat. He asks Alan to enter the house before that and hide in the kitchen and when she comes to the kitchen at 7.15, Michael will make a call to their landline which is fixed in the kitchen, as soon as Gwyneth takes the phone call, Alan will attack her from behind and kill her, he also insists that Alan should not cut the phone and let Michael listen to her screams and pain and enjoy every bit of it.
